

Credit by Examination For Acceleration

Deadlines, Costs, Scoring/Reporting

- ❑ To arrange for the test to be ordered, parents must request test application forms for each test or grade from their school counselor's office and return the forms to their school counselor no later than the dates posted on page 2.
- ❑ A **refundable deposit of \$18.00** is required for each exam ordered. Deposits will be refunded after the student sits for the exam.
- ❑ The tests will be scored by the test publisher and the results sent to the school district approximately four weeks after the final testing date. School counselors will notify the parent/guardian of the results.

NBISD Board Policy

NBISD Board Policy: CREDIT BY EXAMINATION WITHOUT PRIOR INSTRUCTION

- A. The District shall accelerate a student in grades 1–5 one grade level if the student meets the following requirements:
 1. The student scores 80 percent or above on a criterion-referenced test for the grade level to be skipped in all of the following areas: language arts, mathematics, science, and social studies;
 2. A District representative recommends that the student be accelerated; and
 3. The student's parent or guardian gives written approval of the acceleration.
- B. The District shall give a student in grades 6–12 credit for an academic subject in which the student has received no prior instruction if the student scores 80 percent or above on a criterion-referenced examination for acceleration for the applicable course. If such credit is given, the District shall enter the examination score on the student's transcript.

(NOTE: The awarding of credit does not guarantee acceleration of the course sequence due to potential problems with individual teacher certification requirements and numbers of students enrolled in courses. In order to accelerate one grade level, the student MUST pass all four core subject area tests by the criteria of 80.)

- I understand that I must pay **\$18.00** per test as a deposit. Checks should be made payable to **NBISD**. The deposit will be refunded after the student sits for each test. If the student does not sit for a test, the deposit for that examination will be forfeited.
- I understand that my student must arrive by the posted start time since the exam is timed and requires extensive instructions to be read beforehand. Failure to arrive by the posted start time may result in the student not being allowed to test during that session. Every attempt will be made to reschedule during the posted testing dates.
